



## **Basic Jail Academy/Secure Juvenile Detentions Academy**

Gateway Technical College's 184-hour **Basic Jail Academy**/Secure Juvenile Detentions Academy offers students the opportunity to become certifiable as a **Basic Jailer** or Secure Juvenile Detentions officer within the state of Wisconsin.

Academy recruits can be:

- those seeking the training needed to obtain an entry position as a County Jailer, Correctional officer, or Secure Juvenile Detentions officer.
- those also already hired by a County agency needing training.

Students will receive top-flight instruction which will prepare them well for the rigors and skills needed to be a **Basic Jailer**/ Secure Juvenile Detentions officer in Wisconsin.

The intense, 184 hour **Academy** is scheduled 12:00 p.m. to 8:30 p.m. Monday through Friday, one week a month for four months.

### **The Academy dates are scheduled for:**

- **April 16<sup>th</sup> to April 20<sup>th</sup>, 2018**
- **April 23<sup>rd</sup> to April 27<sup>th</sup>, 2018**
- **May 21<sup>st</sup> to May 25<sup>th</sup>, 2018,**
- **June 18<sup>th</sup> to June 22<sup>nd</sup>, 2018 and,**
- **June 25<sup>th</sup> to June 27<sup>th</sup>, 2018**

Completion of the Jail Officer/Secure Juvenile Detentions-184 hour Basic Training Course meets State of Wisconsin Law Enforcement Standards Board requirements for certification. Employed candidates become certified upon presentation of their academy transcripts to the Standards Board and upon board approval. Candidates seeking employment have three years from completion of the course to secure a County Jail Officer position in order to become certified.

Cost for the program is \$725.00.

### **Entrance requirements, self-sponsored:**

- Be at least 18 years old

- Be a citizen of the United States
- Complete an oral interview with a panel
- Undergo a criminal history records check
- Undergo a physical assessment
- Complete a [DJ-LE-330 form](#)

**Entrance requirements, agency sponsored:**

- Agency must complete and send in a DJ-LE-303 form prior to officer beginning training. This form is available only through the Department of Justice, Carolyn Olson, (608) 264-6377.

**Students are required to provide**

- Black tactical pants
- Black tactical boots or black cross training shoes

**Apply to the academy, application packet:**

1. Verification of birth certificate. An **official birth certificate** must be presented in person and verified by the Academy office. **DO NOT SEND IN COPIES.**
2. Obtain a copy of your high school diploma.
3. Complete the [DJ-LE-330 form](#), Application for Employment as a Law Enforcement, Jail or Secure Juvenile Detention Officer. You must complete the questions in Section 6.

**Applications must be submitted by 4:00 p.m., April 11<sup>th</sup>, 2018.** All application materials must be turned in to the Law Enforcement Academy Office prior to the oral interview. Completed applications will be reviewed and those chosen will be invited to interview with a panel of criminal justice executives.

*Incomplete applications will not be reviewed or accepted.*
